

Ascended Ideas Author Agreement

Ascended Ideas (AI) provides ePublishing services and print on demand advice for the author as well as online bookstore space for the digital books and/or links to such sites as the author places the work. AI is an ePublisher but does not retain exclusive rights to the work, nor does AI promise beyond those outlined in this agreement.

Authors are free to list and sell their work elsewhere in conjunction with AI. The author may also withdraw their work from AI.com at any time for any reason with reasonable notice. If, however, an author withdraws work within 30 days of completion of the PDF publishing phase, they will be subject to a fee of 100.00 USD for time and work invested by AI. Additional fees will apply if AI provides cover art and/or interior art. We are not a free editing or graphics service, we invest in you and your work with a reasonable expectation of profit for both the author and AI.

Rights Granted to Ascended Ideas

The author grants non-exclusive publishing rights to AI to produce and distribute the work in digital format including but not limited to disk, CD ROM, PDF file, PDA specific files, and other known and unknown storage mediums.

AI claims no other rights to the work.

Submissions Clauses

The author herein attests the work submitted to AI is free and clear of any incidences of libel, plagiarism, breach of privacy, or misrepresentation of facts.

The author also agrees to repay AI for any legal fees incurred if legal action results from any deliberate or unintentional libel, plagiarism, breach of privacy, or misrepresentation of facts, copyright infringement, or any other legal dispute that may occur related to the work or any part therein (including characterization, concept, or plot).

The author guarantees that biographical or 'as told to' works are, to the best of the Author's knowledge, factual and true.

The author hereby states that the work submitted to AI does not infringe on the privacy of a third person or persons; that the author owns any and all trademarks or trade names connected to the work or used therein; that the work does not constitute obscenity (we do not however consider tasteful erotic content to equate with obscenity), hate literature, or other illegal content and that the author is legally able to enter into this agreement.

The author states that the work is not currently in the public domain; and the author is the sole owner (or joint owner in which case all authors must sign an agreement) and copyright holder of the work with full power to enter into this agreement.

If the work has been previously published, the author states they have full legal right to enter into this agreement.

The author releases AI from any legal actions resulting from the actions of the author or the content of the work.

The author agrees not to enter into another transaction with any other person, firm, or corporation that will conflict with the rights granted to AI as stated in this agreement without first terminating the author's contract with AI.

The author will register and retain all copyright to the work.

AI reserves the right to stop advertising and selling any work involved in any legal dispute, active or pending.

The author agrees to submit the work according to AI's policies.

If, during the life of this agreement, any entity makes unauthorized use of the author's work, it is the author's sole responsibility to take legal action and the author will bear all expenses, and therefore any remuneration gained as a result.

Format of Work

1. AI will make the work available in a minimum of 2 formats: digital file (PDF) for download and on fixed disk. If later technology allows, files may also be converted to PDA specific formats or other formats as yet unknown.

A. The author acknowledges that, due to the nature of those files, it is possible for them to be replicated and illegally distributed once they are purchased which is outside the control of AI. The author agrees not to hold AI responsible if such a situation occurs.

2. Digitally formatted works are not required to have an ISBN. Works in print should for greater salability and marketability. ISBN numbers are included in most print on demand service packages, but obtaining one not an AI responsibility.

Annual Review of Sales

1. Once yearly a work will be assessed for sales viability. If the work has no sales for one year plus 30 days, it will be withdrawn from AI listings.

Service Provided by AI

1. AI will make the work available for sale on the AI website in eBook format.

2. AI will link to any other distribution channels the author has chosen (e.g. POD distributors or online bookstores).
3. AI will fulfill orders for the work in digital formats outlined above.
4. AI will handle customer support inquiries resulting from AI distribution.
5. AI will distribute the author's commissions on sales on a quarterly basis.
6. AI will provide copyediting and cover/interior art design with the stipulation that the author remain listed on the AI website a minimum of 30 days.
 - A. If the author withdraws from AI prior to 30 days, the author will pay AI a 100.00 USD fee for editing services and/or other fees related to graphics services.

Pricing of Work

The minimum price for an eBook is 4.95. Actual pricing will be calculated based on graphics, page and/or word count, and other factors. Royalty rates begin at 50% and can be as high as 70%.

The author is free to market and sell the work via other sales channels. However, the author agrees not to sell the eBook version of the work through outside sales channels for a list price less than the price listed on AI.

Royalty Payments

Royalties are made on a quarterly basis. The author is free at any time to request an audit of accounting procedures at their own cost.

Royalties are paid only on sales deemed final (i.e. check clearing bank accounts, credit card charges cleared).

If a sale deemed final is later reversed (due to unforeseen circumstances such as illegal credit card use or other events), the royalty paid will be deducted from the next royalty payment due.

In the case of multiple authors, AI will issue one payment in all parties' names. Authors are asked to designate a payee to receive payments.

Communications with Authors

The primary means of communication prior to publication is expected to be through email. Postal mail can be used if necessary.

Royalty checks will be issued through postal mail unless other arrangements are made through a service like Paypal.

If royalty checks are returned for three consecutive months, further checks will be held until the author contacts AI. It is the author's responsibility to contact AI with any address changes or other circumstances which might affect delivery of royalties.

At six months, one last attempt will be made to contact the author. If it is unsuccessful, royalties accumulated will be donated to a charitable fund of AI's choice and the work will be removed from the site.

Promotion of Work

AI does not support spam in any form and does not mass mail market any work. AI further will not support an author who practices mass email and will terminate any author discovered engaging in the practice.

AI will have the right to use the author's name (or pen name), likeness, and biographical information in promotional material for the purpose of advertising, promoting, and publishing the work.

AI has the right to use excerpts of the work for the purpose of advertising, promoting, and publishing the work.

AI reserves the right to distribute free copies to reviewers for the purpose of advertising and/or promoting the work.

General

AI shares business related information with the author. The author agrees not to share that information or to use that information to enter into business competition with AI.

While AI will make every effort to keep the website current and online, but shall not be held responsible for events beyond its control.
